

LITERATURE CITED

This is a consolidated list of all works cited in volume 1. In the entries for articles, serial titles are cited by the abbreviated forms recommended in G. D. R. Bridson and E. R. Smith (1991). Cross references to the corresponding full serial titles are interpolated in the list alphabetically by abbreviated form. Two or more works published in the same year by the same author or group of coauthors will be distinguished uniquely and consistently throughout all volumes of *Flora of North America* by lower-case letters (b, c, d, ...) suffixed to the date for the second and subsequent works in the set. The suffixes are assigned in order of editorial encounter and do not reflect actual chronological sequence of publication. The first work by any particular author or group from any given year carries the implicit date suffix "a"; thus, the sequence of explicit suffixes begins with "b". In two cases, this list includes citations with dates suffixed "b" that are not preceded by citations of "a" works (i.e., ones with no date suffix) for the same year. This does not reflect omissions here, but rather that there are corresponding "a" works cited (and encountered first from) elsewhere in the *Flora* that are not pertinent here.
